VYSA is seeking an Assistant Manager of Facility Operations to work at the **Publix Virginia Soccer Training Center (PVSTC)** in Fredericksburg, VA. This position is a full-time salaried exempt position with the **Virginia Youth Soccer Association (VYSA)**. The employee must be able to work non-traditional hours including evenings and weekends as needed. This position reports to the Director of Facility Operations. The duties include assisting the Director of Facility Operations with the oversight, maintenance, and customer service at PVSTC.

EXPERIENCE AND QUALIFICATIONS

- A minimum of one (1) year of professional experience in facility or turf management operations. Experience at a soccer facility is preferred.
- A college degree in Sports/Facility/Event Management is preferred but experience will be considered in lieu of a degree.
- Detail oriented, strong interpersonal skills, self-starter with a strong work ethic.
- Must be willing to work nights and some weekends.

PRIMARY RESPONSIBILITIES

- Supervision of field rentals and facility use (ODP, Coaching Education, Cups, etc.).
- Facility maintenance to include mowing, field painting, herbicide treatments, etc.
- On site support and/or supervision of events (as assigned) at PVSTC.
- Assisting with event set-up and tear down
- Maintaining a high standard of cleanliness at the facility.
- Ensure all operations are carried out in compliance with local and national regulations.
- Assist management with risk management assessments and offer recommendations.
- Oversee the safe storage of equipment inventory.
- Provide outstanding customer service and resolve issues swiftly.
- Ensure compliance and priority of all health and safety regulations.
